Chair's Report – 2025 Annual General Meeting
Donald Vass, Chair, Pompey Supporters' Trust

Welcome to the 2025 Annual General Meeting of the Pompey Supporters' Trust. This is the sixteenth AGM in the Trust's history, and I think it's worth reflecting on the journey the Trust and the club have been on in that time, since the PST was first formed in 2009. Back then, supporter engagement barely existed at all at Pompey. It was the initial goal of the group to open up lines of communication between the club and its increasingly-concerned fanbase, with absent owners steering the club towards administration.

Now, sixteen years on, Pompey is widely recognised as one of the best clubs in the country for supporter engagement and serves as a model to others. In December, we were at the FSA Awards to receive the 'Best Supporter Engagement' award alongside the club, following an earlier nomination at the EFL Awards in the same category. This recognition reflects the hard work not just of the last season, but of the past sixteen years in establishing meaningful and effective fan engagement channels.

Our core work at the Trust is maintaining this regular dialogue with the club, helping to ensure that supporters' voices are heard. We meet regularly with the club's owners and key staff, and bring forward fans' concerns and questions in order to hold the club to account and help bring about positive change for the benefit of everyone connected to Pompey.

In August, we met with staff at the newly-formed Independent Football Regulator, who commented that Portsmouth FC is a stand-out example of what supporter engagement should look like and can achieve. We're grateful to the club's leadership team, led by Andy Cullen, who continue to engage with supporters so positively, putting the club's fans at the heart of their decision making processes.

Alongside our work on supporter engagement, we were proud to launch our new Away Ticket Scheme this year, designed to widen access for high-demand away fixtures. We remain staunch supporters of the club's loyalty point system – it's fair and correct that fans who travel regularly to games should get priority access to high-demand fixtures, and that the vast majority of tickets are distributed in this way. But our scheme has enabled around 2% of the club's total allocation to be made available to supporters on a ballot system, which means those without the necessary points still have an opportunity to attend away games. This has proved really popular, and has grown membership of the Trust by around 10%.

Our second annual supporter survey again provided us with a valuable tool for gauging the views of the wider fanbase. Over 1,000 supporters took part, and the results directly informed our discussions with the club. Two of the most commonly-requested suggestions were to do with ticketing – fans told us they wanted the loyalty point scheme to be adjusted to make it fairer, and that they wanted to receive more money back from the club when they listed their season ticket seat on the club's ticket exchange. Following the survey, we took the results to the club, and both of these changes were implemented ahead of the 24/25 season. This was a clear example of how constructive engagement can lead to meaningful policy change that benefits ordinary fans.

The football team's return to the Championship has meant higher profile fixtures, and the PST has worked constructively with Hampshire Police in connection with several fixtures in the last year, most notably in preparation for the south coast derby. Though we spoke out in opposition to the principle of enforced coach travel, the constructive discussions held ensured the concerns of Pompey fans were heard and acted upon, helping to make the arrangements a success. There were a number of tangible benefits to supporters as a result of supporter engagement, including having multiple pick-up points and a reduction in the

cost of the official travel. It was a good demonstration of what can be achieved when supporters, authorities, and the club work together in good faith.

Our AGM will run across two separate events, beginning tonight by staging the formal part of our AGM, where we can give an overview of our activity over the last 12 months, present our financial accounts, and vote on motions put forward by members. We've once again opted to host this online, ensuring that PST members can attend regardless of location.

We will follow this up with a members event held in person at Fratton Park, where I'm delighted to say we will be joined by John Mousinho, Richard Hughes and Andy Cullen. This will be an exciting opportunity to meet and speak with the trio leading our club. The event will take place on the evening of Monday 17th November. 1. ORDINARY BUSINESS

1.1. Apologies

Apologies were received from: PST Board members Mike Briscoe (MB) and Phil Sandys (PS); PST Board officer Steve Hatton (SH); and PST members Mike Hayward and Mike Broad.

1.2. Report by PST Chairman (Donald Vass)

DV began by paying tribute to “two titans of the PST”: Simon Colebrook, who has stepped down from his role as chairman but continues on the Board as Treasurer; and Jo Collins, who has retired after 15 years on the Trust Board.

PST Chairman's Written Report

Welcomed members to the 2024 Annual General Meeting of the Pompey Supporters' Trust (fifteenth AGM), a significant landmark in the society's rich history. This follows a truly historic campaign for the football club, in which we celebrated the club's 125th anniversary season with promotion for both the men's team and women's side. It was a hugely successful and enjoyable year on the pitch, and we're really proud of what the Pompey Supporters' Trust was able to achieve too.

We began the 23/24 season, almost exactly one year ago to the day now, by unveiling the Jimmy Dickinson statue, following our successful Crowdfunding campaign. We're so delighted with the artwork produced by the sculptor Douglas Jennings – I remain convinced that it's one of the best statues in world football. I'm so grateful to everyone who donated to the campaign, bought one of the books which helped to raise the total, or just supported what we were doing. It was a nerve-wracking moment when the cloth came off to reveal it for the first time, but I'm delighted the response has been so positive, and it's a huge source of pride seeing people interact with it on a matchday. Being able to bring this legendary figure to life for younger and future generations is a wonderful legacy we've been able to contribute to the 125 celebrations. I'm pleased to say that the area around the statue is due to be refreshed and updated shortly, incorporating the club's Hall Of Fame wall and some added greenery.

Throughout the season, we continued in our main role, facilitating fan engagement between the supporters and the club through a number of different channels. We hosted a Q&A event at Fratton Park Andy Cullen, John Mousinho and Rich Hughes, where our members could hear from the men shaping the future of our club. The Matchday Experience Working Group we help to run was nominated for an EFL Fan Engagement Award after playing a role in

improving the catering offer at the ground. We further improved the Tony Goodall Fans' Conference, having partnered with Her Game Too to result in greater female representation in these meetings. The club, led by Andy Cullen, have continued to engage in supporter meetings with genuine openness and a willingness to act on feedback, which has led to tangible improvements across many areas of the club.

In order to represent the opinions of supporters more accurately, we carried out a supporter survey in March to canvas the views of the wider fanbase. Nearly two and a half thousand fans took part – this gave us an incredibly useful snapshot of which topics fans cared most about, and how successful they viewed current performance in these areas. As well as publishing the results in full, we shared the results with the club, and recorded a video interview discussing the key findings with Andy Cullen for the club's YouTube channel.

As a result of the survey, we commissioned a new street art mural featuring 6 iconic modern Pompey heroes on the side wall of the club shop, chosen by supporters. This was a really fun project to lead on, and resulted in some good-natured debate among the fanbase over who should feature. The six names to eventually top the poll - Alan Knight, Guy Whittingham, Kanu, Linvoy Primus, Paul Merson and Robert Prosinečki – should spark off many happy memories whenever fans walk past the mural on a matchday.

To cap off the 125th anniversary season, we staged a fan 'tifo' display in the Fratton End for the final home game of the season. This was a challenging project to organise, with nearly 5,000 cards to place accurately overnight ahead of the fixture. I'm hugely grateful to the PST board members who gave up their time to do this, and to the Fratton End ticket holders who held them up in unison to create a striking visual image to mark the end of this special campaign. Thanks to a commercial sponsorship, I'm pleased to say we were able to stage this project without any cost to supporters, and at almost no cost to the Trust.

There are various other activities we've been involved in this year. We've continued to provide half time refreshments for our disabled supporters in the Fratton End, to help them on those cold winter nights. Our Treasurer Simon Colebrook provided an independent review of the club's accounts, to help fans understand what they mean in plain English. We've provided a small donation to help with the formation of the Women's Supporters' Club, reflecting the growing importance of the women's team to the club, and further funding for the 125th anniversary photography exhibition held this summer.

As we move into the 24/25 season, we look forward to another successful campaign on and off the pitch. We begin tonight by staging the formal part of our AGM, where we can give an overview of our activity over the last 12 months, present our financial accounts, and vote on motions put forward by members. We've once again opted to host this online, ensuring that PST members can attend regardless of location.

We will follow this up with a members' event held in person at Fratton Park, where I'm delighted to say we will be joined by John Mousinho, Richard Hughes and Andy Cullen. This will be an exciting opportunity to meet and speak with the trio leading our club. The event will take place on the evening of Wednesday 6th November. Tickets will be available free to members, and we will email a link through which you can book these shortly.

TREASURER'S REPORT TO THE MEMBERS

For the year ended 30 June 2024



1. Summary

The 2023/24 season was a busy one, financially speaking. We finished off the fundraising for the Jimmy Dickinson Statue and the costs of its installation and unveiling. We also successfully applied for a grant from the Arts Council England that helped with those installation costs, as well as funding several arts projects that helped both celebrate PFC's 125th anniversary and the culture impact of the club on its fans and the city.

Keen readers of the accounts will note that the statue does not appear as an asset in the accounts. I will go into more detail on this later in my report, but in summary accounting rules for assets don't allow us to include the statue as one for accounting purposes.

Our funds remain at a healthy cash balance of £49,287, which gives us scope for a limited amount of community work before any need to carry out any specific crowdfunding.

2. Audited Financial Statements for the year ended 30 June 2024

The Society's income for the year was £42,857, compared to £56,572 in the previous year.

Our regular recurring income of Membership fees and general donations saw an increase in the year, which is welcome as this is what pays for the regular annual costs of the Society.

The specific income relating to the statue decreased a lot, reflecting the end of the fundraising period as we moved into the installation phase of the project.

Our regular running costs stayed largely the same at a shade below £2,000. In addition to this we made a donation of £200 to the newly formed Portsmouth Women's Supporters Club to help them with the costs of setting up their website and mailing systems ahead of getting their paid memberships up and running.

The expenditure on the statue means that our General Reserve has fallen into a significant deficit, however we continue to have an overall positive Members' Funds due to the Community Share that were left in the Society by Community Shareholders that chose to not withdraw their shares when we sold the club.

We retain just under £50k in the bank, which will allow us to do modest community activities in line with our objects. Any larger scale projects will be crowdfunded.

Although our membership fee has been unchanged for 15 years, we do not propose to increase it. Our membership income is easily sufficient to cover our regular annual costs, and we would therefore only be collecting money for the sake of it. The Society Board would prefer to crowdfund any major community projects directly rather than generate the funds through membership fees before we know what we plan to spend it on.

3. Jimmy Dickinson Statue

The acquisition and installation of the statue was a major project involving funding from a wide range of partners – our members, other fans of PFC, former Presidents of the club, Tornante, PMC, the club itself and the Arts Council England.

Collectively we crowdfunded approximately £80k from members and former Presidents. Combined with an allocation from the Art Council Grant and our own reserves, this paid the £121k cost of the statue. Full detail of this is included in Note 3 of these accounts.

Tornante, the Club and PMC generously funded the additional costs of landscaping the area around the statue and installing it in place. This saved us a significant amount of money.

I mentioned earlier that statue does not appear as an asset in these accounts. Our auditors have advised us that accounting rules state that any object that is purchased can only be included as an asset if it will contribute to our ability to generate economic benefits for the society. There is no scope for including an item of expenditure as an asset if it does not do so. This may seem somewhat nonsensical given that there is a tangible statue that everyone can see on a matchday, but they are the rules in the relevant accounting guidelines.

The Society Board emphatically believes that the statue is the PST's gift to the fans and our community, and thus should be freely available to all to view and that we will not seek an income from it. We believe that the funding of the statue is a great collective achievement by the PST and everyone who contributed to the project. And that, regardless of the impact on our reserves, this project makes such a massive contribution to the collective appreciation of the club's history and culture that the use of our funds to help enable it to happen was entirely appropriate.

4. Other 125 anniversary and community contributions

In addition to the statue, we also funded two projects for the anniversary celebrations. £12,000 was spent commissioning the fantastic mural on the side of the club shop depicting legends from the club's recent past. We also contributed to the costs of a photography exhibition depicting Pompey through the ages that was organised by the Pompey History Society.

5. Looking ahead

As mentioned, we hold approximately £50k in the bank. We have no confirmed major expenditure at this time. We are in the process of working on an update to the website to freshen it up and improve its function that will incur some costs

6. Reappointment of Auditors

I'd like to express my gratitude to Taylor Cocks for once again providing us with audit services free of charge and I recommend their reappointment as auditors for 2025.

2. SPECIAL BUSINESS (Motions)

However, three questions / comments were raised by Members:

- (1) Now the Club is in the Championship with costs up and income similar, what insight does the Board have as to how the Club proposes to cover this loss? DV said the Championship is a loss-making Division and the Club anticipate making a slight loss this season. The hope is to increase the value of players. SC said he hasn't seen the Club accounts for last season in League One, but the TV deal for this season is worth an extra £7m and ticket revenue is likely to increase by 10-15%. Revenue is likely to be about £20m, most of which will go on players' wages.
- (2) Are the accounts for the women's team separate from the men's? SC said yes, the women's club is a separate company, but the model is a lot more challenging because the income levels are so much lower.
- (3) The view of the media gantry and the new landing in the North Stand have received a very good response from fans.

1. Summary

After the excitement of the fundraising and successful delivery of the Jimmy Dickinson Statue, 2024/25 saw the Trust's finances return to a more normal level of activity.

We received £2,075 in sponsorship from Total AV to cover the cost of the Tifo display at the start of the season which was much appreciated.

Membership income was largely unchanged from the previous year. Our running costs were higher due to increased costs of running the website, leading to a reduced surplus from general operations.

With the surplus from the Tifo added we ended the season with an overall surplus of £5,674, compared to a deficit in 2023/24 of £95,741, however this was as a result of the recognition of the costs of the statue in that period.

Our funds remain at a healthy cash balance of £57,461, an increase from the previous year.

We retain just over £57k in the bank, which will allow us to do modest community activities in line with our objects. Any larger scale projects will be crowdfunded.

As in last year, although our membership fee has been unchanged for 15 years, we do not propose to increase it. Our membership income is easily sufficient to cover our regular annual costs, and we would therefore only be collecting money for the sake of it. The Society Board would prefer to crowdfund any major community projects directly rather than generate the funds through membership fees before we know what we plan to spend it on.

3. Independent Football Regulator

As well as the financial affairs of the Trust, I have taken a lead on the PST involvement in the setting up of the new Independent Football Regulator (IFR).

We have worked with the staff of the new regulator to help shape their thoughts on the standard of engagement that should apply throughout the game. Much of the draft licensing regime reflects our experience and the structures we have built for PFC, both during fan ownership and since. We will continue to advise the IFR through a new Fan Advisory Panel that we have been invited to join.

4. Other Football Engagement

As well as the work with the IFR, we have also worked with the Football Supporters Association in engaging with the FA, the EFL and the new Womens' league organiser, the WSLF. In each of these we have addressed issues affecting the wider football community, and providing examples of how they impact on PFC, and its fans.

Recent examples of our engagement include commenting on the impact of moving fixtures for TV, and commenting on plans to restructure women's football that would have been disadvantageous to PFC Women.

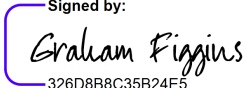
Auditor's responsibilities for the audit of the financial statements

These financial statements have been prepared in accordance with FRS 102 “The Financial Reporting Standard applicable in the UK and Republic and Ireland” (“FRS 102”). The financial statements are prepared in sterling, which is the functional currency of the company. Monetary amounts in these financial statements are rounded to the nearest £.

The Jimmy Dickinson Statue is an object of historical and cultural importance to Portsmouth Football Club and its fans. It was funded by a combination of Society reserves, donations from fans of Portsmouth Football Club, and a grant from the Arts Council England.

The Society Board has decided that it should be freely available to both fans of Portsmouth Football Club and the general public for viewing, and that no income will be sought from ownership of the statue. As the statue will not generate an economic return, it does not qualify as an accounting asset under FRS102 and has therefore not been recognised as such in the Balance Sheet.
