

Ordinary Shareholder Ballot on the PST contribution to the Purchase of Moneyfields Park

Dear PST Member,

Re: Indicative Ballot on the purchase of Moneyfields Park

At the tenth AGM of the Portsmouth Supporters' Society held on Wednesday, 30 October 2019 - members voted in favour of a consultative ballot (indicative approval) on the PST contribution to the redevelopment of Moneyfields Park, Burrfields Road, Portsmouth, PO3 6LD. PST Chairman, Simon Colebrook, informed members at the Tenth AGM that an opportunity had arisen for Pompey in the Community (PiTC) to be gifted the freehold of Moneyfields Park and to redevelop it for the use of PiTC, Moneyfields FC and Portsmouth FC Women. If successful, this would provide two full size pitches and new community facilities for the charity and the two community teams. The estimated cost of the purchase is £3.5 million, with potential for public funding of £2 million.

The proposal is that PST contribute up to £250,000 towards the redevelopment of Moneyfields Park, Burrfields Road, Portsmouth, PO3 6LD.

The ballot opens on Sunday, 12 January (midnight), and all votes cast must have been received by the Returning Officer by **6pm** on **Saturday, 25 January 2020**. When you have made your choice, please email to moneyfields-ballot@pompeytrust.com.
